## Chief Justice President of the Supreme People's Court The People's Republic of China

Born in Hubei Province in April 1960.

He graduated in 1982 from the Law School of the Southwest College of Political Science & Law which is now the Southwest University of Political Science & Law (SUPSL) and got Bachelor Degree in Law; then graduated in 1985 from the Graduate School of the SUPSL and got Master Degree in Civil Law.

From 1985 to 1995, he worked in the Ministry of Justice as an official of the Research Department; Deputy Division Director, Division Director of the Legislative Affairs Department; Deputy Director-General of the General Office and Director of the Minister's Office; Director-General of the Legislative Affairs Department.

From 1995 to 2006, he was Secretary, Executive Secretary, First Secretary of the Secretariat of the Central Committee of the Chinese Communist Youth League (CCYL).

From 2006 to 2010, he was Deputy Secretary of Hunan Provincial Committee of the Communist Party of China (CPC); Acting Governor and Governor of Hunan Province.

From 2010 to 2013, he was Secretary of the CPC Hunan Provincial Committee; Chairman of the Standing Committee of Hunan People's Congress.

In March 2013, he was elected the President of the Supreme People's Court and became the Chief Justice of the People's Republic of China. In March 2018, he was reelected as the President of the Supreme People's Court.

He is concurrently the President of the Chinese Judges Association and the President of the Chinese Judicial Studies Association.


From 2005 to 2007, he was the Vice President of Huangpu District People's Court of Shanghai Municipality.

Ms. Andersen has more than 30 years of experience in international development economics, environmental sustainability, strategy and operations. She has led work on a range of issues including agriculture, environmental management, biodiversity conservation, climate change, infrastructure, energy, transport, and water resources management and hydro-diplomacy.

Between 1999 and 2014, Ms. Andersen held several leadership positions at the World Bank including Vice President of the Middle East and North Africa; Vice President for Sustainable Development and Head of the CGIAR Fund Council.

Prior to her 15 years at the World Bank, Ms. Andersen worked 12 years at the United Nations, first on drought and desertification, beginning with the UN Sudano-Sahelian Office. In 1992, she was appointed UNDP's Water and Environment Coordinator for the Arab Region.

Ms. Andersen holds a Bachelors from the London Metropolitan University North and a Masters in Development Economics from the School of Oriental and African Studies, University of London.

#### **Executive Secretary of the Secretariat of the Convention on Biological Diversity**

United Nations Secretary-General António Guterres, following consultation with the Bureau of the Conference of the Parties to the Convention on Biological Diversity (CBD), announced on 8 June 2020 the appointment of Elizabeth Maruma Mrema of Tanzania as Executive Secretary of the Secretariat of the Convention on Biological Diversity.

Since December 2019, Ms. Mrema has been the Acting Executive Secretary of the CBD Secretariat. Prior to that, Ms. Mrema served as Director of the Law Division at the United Nations Environment Programme (UNEP) in Nairobi, Kenya. With over two decades of experience at the United Nations, Ms. Mrema brings to the position extensive experience in global environmental law and policymaking, implementation of environmental and sustainable development programmes, and a deep knowledge of multilateral processes. From 2009 to 2012, she served as the Executive Secretary of the UNEP/Secretariat of the Convention on the Conservation of Migratory Species of Wild Animals as well as served as the Acting Executive Secretary of the UNEP/ASCOBANS (Agreement on the Conservation of Small Cetaceans of the Baltic, North East Atlantic, Irish and North Seas) as well as Interim Executive Secretary of the UNEP/Gorilla Agreement, all based in Bonn, Germany.

Before joining UNEP, Ms. Mrema worked with United Republic of Tanzania's Ministry of Foreign Affairs and International Cooperation. During her time with the Ministry, she also lectured in Public International Law and Conference Diplomacy at Tanzania's Centre for Foreign Relations and Diplomacy.

In 2012 he led the planning and organization of the first World Congress on Justice, Governance and Law for Environmental Sustainability as part of the UN Conference on Sustainable Development (Rio+20).

Before joining UNEP, Arnold has worked in the governmental, non-governmental and in the private sector.

He holds a doctorate degree in international environmental law from the University of Vienna as well as a master's degree in advanced international studies from the Diplomatic Academy of Vienna.

#### President of the Supreme Administrative Court The Republic of Finland

Kari Kuusiniemi (born in 1960) holds Master of Laws (1982), Licentiate of Laws (1985), and Doctor of Laws (1992) degrees, from Helsinki University. Before being appointed President of the Supreme Administrative Court (1.9.2018), he has served as Justice at the same Court since 2002, including presidency of Chamber (1.3.2012-2018), and vice-presidency of the Court. Before the career as judge he was Professor of Environmental Law at the University of Turku (1996-2002) and acting Professor of Law (1993-1995) and Lecturer in Environmental Law (1991-1993) at Helsinki University of Technology.

Other activities include: Docent of four Finnish Universities, visiting professor at the University of Louisville, Kentucky (September-October, 1997), Expert in the South-African Water Law review (1995-1996), Chairman, member and secretary in several law drafting commissions since 1985, Member of ERA Board of Trustees (2010-2019), Member of the Board of the National Defence Course Association (2011-), Chairman of the Board (2020-), Member of the Board of the Finnish Association of European Law (2014-) and Member of the Academy of Science and Letters (2014-)

He has published some 20 books (partly joint publications) and some 200 articles, reports, case comments, etc. in the field of Environmental and Administrative Law, mainly in Finnish.



**Laurent Fabius** 

### President of the Constitutional Council The French Republic

Born 1946 in Paris, Laurent Fabius is a former student of the Ecole Normale Supérieure of the Rue d'Ulm, holder of an Agrégation higher degree in French Language and Literature and a former student of the Ecole Nationale d'Administration. Member of the "Conseil d'Etat", Laurent Fabius occupied several governmental positions in France: Minister for the Budget (1981-1983), Minister of Industry and Research (1983-1984), Prime Minister (1984-1986), Minister for the Economy, Finance and Industry (2000-2002), Minister of Foreign Affairs and International Development (2012-2016). He was also Member of Parliament from 1978 to 2012, and served twice as President of the French National Assembly, from 1988 to 1992, and again from 1997 to 2000. In 2015, as President of the COP 21, he played a crucial role in the negotiations that led to the Paris Climate Agreement, the first universal agreement to fight against climate change. In February 2016, he was appointed President of the Constitutional Council of the French Republic.

Since 1977 – president of the people's district court for Zheleznodorozhniy district in Moscow.

Since 1984 – deputy president of Moscow City Court.

Since 1986 – president of Moscow City Court.

July 1989 – first appointment as Chief Justice of the Supreme Court of the Russian Federation.

Chief Justice Lebedev is a Full Cavalier of the state order "For Services to the Fatherland". He has been decorated with multiple governmental and state awards.

He was awarded the Order of Alexander Nevskiy in 2012 and the Medal of Pyotr Stolypin, 1st degree, in March 2013.

Justice Mandisa Muriel Lindelwa Maya is the President of the Supreme Court of Appeal of South Africa (SCA).

She holds B.Proc. (University of Transkei), LLB (University of Natal, Durban) and LLM (Duke University, USA) degrees and three LLD (Honoris Causa) degrees awarded by Nelson Mandela University, Walters Sisulu University and University of Fort Hare, in recognition of her contribution to the development of jurisprudence in South Africa as well as the empowerment of women in the legal profession and the judiciary. She is a Fulbright; Georgetown University Law & Gender Program; and Commonwealth Foundation Fellow and is the recipient of the 2020 Duke University Law International Law Alumnus Award.

After teaching law at the former University of Transkei, while also practising at the Transkei Society of Advocates, she became a judge and sat in various divisions of the High Court and the Labour Courts before her elevation to the SCA. She became the first woman Deputy President of the SCA in 2015 and its first woman President in 2017. She has acted as a judge in the Constitutional Court of South Africa, the Supreme Court of Namibia and the Appeal Court of Lesotho. She promoted law reform as the Chairperson of the South African Law Reform Commission and is a member of the South African Judicial Service Commission, the South African Judicial Education Institute and the Duke University Bolch Judicial Institute Leadership Council, among other leadership positions.

#### Chief Judge of Land and Environment Court of New South Wales The Commonwealth of Australia

Justice Preston is the Chief Judge of the Land and Environment Court of New South Wales. Prior to being appointed in November 2005, he was a senior counsel practising primarily in New South Wales in environmental, planning, administrative and property law. He has lectured in post-graduate environmental law for nearly 30 years. He is the author of Australia's first book on environmental litigation and 139 articles, book chapters and reviews on environmental law, administrative and criminal law. He holds numerous editorial positions in environmental law publications and has been involved in a number of international environmental consultancies and capacity-building programs, including for judiciaries throughout Asia. Justice Preston is an Official Member of the Judicial Commission of NSW, Fellow of the Australian Academy of Law, Fellow of the Royal Society of NSW and Honorary Fellow of the Environment Institute of the Australia and New Zealand. He was awarded an honorary Doctor of Letters by Macquarie University in 2018. He is a member of various international environmental law committees and advisory boards, including the interim governing council of the Global Judicial Institute on the Environment. He is currently an Adjunct Professor at the University of Sydney, Western Sydney University and Southern Cross University. In 2019 Justice Preston was a Visiting Fellow at Corpus Christi College, University of Oxford, and in 2020 was the Robert S Campbell Jr Visiting Fellow at Magdalen College, University of Oxford.

Justice of the National High Court
The Federative Republic of Brazil

Justice Dr. Dr.h.c. mult. Antonio Herman Benjamin, National High Court of Brazil (STJ)


Appointed Justice of the National High Court of Brazil (STJ) in 2006 by President Luiz Inácio Lula da Silva, Professor Antonio Herman Benjamin was a career Public Prosecutor of the State of São Paulo for over two decades, where he headed the Environmental Protection Division. He is a former president of the Brazilian Fulbright Alumni Association and a member of the UN Secretary General Legal Expert Group on Crimes against the Environment. Justice Benjamin is the president of the Brazilian Environmental Forum of Judges (FONAMA) and Director of the L.L.M (Master) Program of the National Judicial Academy of Brazil (ENFAM).

Justice Benjamin was a professor at the Catholic University of Brasília School of Law and has been a visiting professor and lecturer at prestigious academic institutions around the world. He is the founder and emeritus editor-in-chief of the Brazilian Environmental Law Review, published by Thomson Reuters. He has co-drafted several major Brazilian statutes, including the 1990 Consumer Protection Code, the 1992 Anti-Corruption Act, the 1994 Competition Act, the 1998 Crimes Against the Environment Act, the 2006 Forest Concession Act, the 2006 Atlantic Forest Act, and the 2012 Forest Code. Professor Benjamin has authored, co-authored and edited over thirty books and articles in Brazil and abroad.

At the international level, Professor Benjamin served as co-chair of INECE – The International Network for Environmental Compliance and Enforcement and president of the Environmental Committee of the Summit of Chief Justices of Ibero-America. Currently, he is the chair of the IUCN World Commission on Environmental Law – WCEL and secretary-general of the "International"

Advisory Council for Environmental Justice" of UNEP – The United Nations Environment Programme. He is the lead founder of the Global Judicial Institute on the Environment, the organization that brings together Supreme Court Justices and judges from around the world who that work with Environmental Law. During the 2012 Rio+20 Conference, he was coordinator of the UNEP World Congress on Justice, Governance and Law for Environmental Sustainability.

Justice Benjamin has received several awards, honours and other recognitions in Brazil and abroad. He is a Knight (Chevalier) of the National Order of the Legion of Honour (Ordre National de la Légion d'Honneur) of France and a Commander (Commandeur) of the Order of King Leopold of Belgium. He is the recipient of the 2015 Elizabeth Haub Prize for Environmental Law, awarded by Stockholm University and considered the most prestigious international distinction conferred upon an environmental legal expert. He is a Goodwill Ambassador for Environmental Justice of the Organization of American States – OAS.



#### **Swatanter Kumar**

## Former Judge of Supreme Court Former Chairperson of National Green Tribunal The Republic of India

After completing BA LLB from Punjab University, he practiced at New Delhi for 23 years, and then he served as an Additional District & Sessions Judge at the Himachal Pradesh High Court from February, 1983 to October, 1983. He resigned and returned to practice at New Delhi.

During his practice, he was Legal Advisor, Standing Council to various Government and Non-Government Corporations and Public Bodies. He was also Legal Advisor at the Central Board for Prevention and Control of Pollution, which manages matters on pollution for all of India. He has practiced in Criminal, Civil, Appellate, Constitutional, Arbitration and Environmental jurisdictions in all courts including the High Courts and Supreme Court of India.

He was appointed as an Additional Judge of the Delhi High Court on 10.11.1994. Then he was transferred to the Punjab and Haryana High Court on 30.11.1994 from where in 2004, he was transferred to the Delhi High Court.

He was appointed as the Chief Justice of the Bombay High Court on 31st March, 2007 where he had the privilege of serving one of the best High Courts in the country. He had the occasion to deal with a variety of Administrative and Judicial Matters. One of his contributions was to establish courts at the Talukas (at village level). Having served as Chief Justice for nearly a period of three years, he was elevated as Judge of the Supreme Court of India on 18th December, 2009. Upon being appointed as the Chairperson of the National Green Tribunal. He resigned as Judge of the Supreme Court of India on 20.12.2012. He had the occasion to deal with cases in all Jurisdiction including Arbitration Cases of National and International Jurisdiction in the High Courts and the Supreme Court of India.

He joined the National Green Tribunal on the same day. During his tenure, he was instrumental in delivering several landmark judgments widening the horizons of environmental jurisprudence in India. These judgments have related to cleaning of rivers Ganga and Yamuna, Lakes, Air Pollution, Himalayan Glaciers, Municipal Solid Waste and Protection of Forests. Some of his Judgments were of International Scope, like those dealing with oil spills because of sinking ships. He introduced for the first time 'the practice of a consultative process of stakeholders' in the dispensation of environmental justice. In consonance with the legislative intent of enacting the National Green Tribunal Act, 2010 for expeditious disposal of cases, he assured that in the Principal Bench of the NGT, nearly 82% cases were disposed of within the year of his institution. Under his leadership, the National Green Tribunal has held various international as well as Regional Conferences on environment in various parts of the country, where many countries from all across the globe have actively participated and contributed to the burning issues of ecological conservation and climate change. In the National Green Tribunal he disposed of 209 cases in one day.

He disposed of a large number of cases in all fields of law while he was a Judge of the High Court, the Chief Justice of the Bombay High Court and Judge of the Supreme Court. He disposed of 670 cases in a day in the Punjab & Haryana High Court, 80 cases in a day when he was the Chief Justice of Bombay High Court and 75 cases in a day when he was a Judge of the Supreme Court of India. In his long carrier as a Judge of various High Courts and Supreme Court of India, He has enunciated various legal principles, more particularly in the field of constitutional, criminal and arbitration jurisprudence.

For his contribution as a Judge of the Supreme Court of India, Judge and Chief Justice of High Courts and the Chairperson of the National Green Tribunal, he has been bestowed with 12 different Awards including the National Law Day Award, lifetime achievement awards, International Human Rights Award, Bharat Jyoti Award, Distinguished Services Award by the Indian Medical Association and awards by other National and International organizations. He has, during his tenure in the judiciary authored and pronounced various landmarks Judgments in the field of Constitutional Law, Arbitration and Environment Jurisprudence.

He has also been nominated as the member of the Governing Body of the Global Judicial Institute for the Environment which works under the UNEP and has addressed various national and international conferences organized by the United Nations and various other national and international organizations.

It was to promote this educative and awareness driven impetus that he had, during his judicial tenure organized and addressed various lectures, seminars, colloquiums and conferences all across the globe sharing the dias and exchanging ideologies with the highest dignitaries of various countries around the world, including the President, Prime Minister, Home Minister, Minister of Environment of India on various occasions, as well as international dignitaries such as the President of France, Director UNEP, Judges of the Supreme Courts of various Countries and states including

Lord Carnwath, Justice Michael Wilson and Justice Dr. Luc Lavrysen, to name a few. It was in this pursuit that he also availed of the opportunity to address the students and academia at various Universities and institutions around the globe including the University of Houston, Texas, Supreme Court of Hawai'i, UN, Geneva, amongst others. He do believe that in the present times, there is a definite need of academia – input from the legal education to interact with and provide guidance to Judges at various levels of the judicial hierarchy of India.

Post retirement 2017, he has been involved in diverse activities relating to Education, Social and International lectures, in India and Abroad. He has been nominated by parties and as well appointed by the Courts as Sole Arbitrator, Presiding Arbitrator of the Multiple Member Arbitral Tribunal and Member of the Multi Member Arbitral Tribunal.

These Arbitration Proceedings, where he has been nominated or appointed, the opposite party Respondent amongst other is Union of India, State Government, National Highway Authority of India, Public Sector Undertaking Corporations and National and International Companies. He has also been nominated Arbitrator by Foreign Companies in India. In number of cases, Awards have been pronounced or matter settled with utmost expeditiousness.



#### **Syed Mansoor Ali Shah**

### Justice of the Supreme Court The Islamic Republic of Pakistan

Justice Shah was elevated to the bench at the Lahore High Court in 2009 and after serving as the Chief Justice of the Lahore High Court for almost two years was elevated to the Supreme Court of Pakistan in early 2018. He did his schooling at Aitchison College, Lahore and got his law degree from the University of Cambridge, UK, as well as, the University of the Punjab, where he also obtained a degree in Masters in Economics. As a corporate litigator, he was a partner at AFRID, SHAH & MINALLAH and took keen interest in public interest litigation with special focus on environmental issues and sustainable development. He espoused a passion for teaching and taught law for almost two decades at the Lahore University of Management Sciences (LUMS), Pakistan College of Law and Punjab Law College, Lahore. He was also part of the steering committee that established the law school at LUMS, now called Syed Ahmed Hassan School of Law & Policy (SAHSOL).

His areas of special interest are the constitutional law, human rights, climate and water justice, environmental sustainability, disability rights, criminology, digital surveillance, privacy and proportionality. He believes in continuous judicial reforms; he spearheaded the formation of Alternate Dispute Resolution Centers (ADRC) in Punjab as the Chief Justice to provide an alternative to litigation in order to reduce the chronic backlog and staggering pendency of cases. He set up Criminal and Civil Model Courts to create working coordination between stakeholders in order to speed up dispensation of justice, introduced Case Management and Court Automation Systems in Punjab both at the Lahore High Court and the District Courts, installed first ever Enterprise IT System with the help of Punjab Information Technology Board (PITB) to sustain the

IT vision of the court for the next decade and to make the judicial system; open, transparent, smart and fully connected at all levels. To provide access to justice to an ordinary litigant and the lawyers, online Call Centre, Judicial Mobile App and online Sahulat (care) Center were established.

He underlines the need for Information Technology, Artificial Intelligence, Video Linking, Human Resource Development and Restructuring of the District Judiciary as the effective engines of change for the future and would like them to be mainstreamed to achieve state of the art judicial governance. He lays great emphasis on empowering the District Judiciary by enhancing their capacity through international and domestic training, based on performance indicators and by providing them a secure and conducive working environment, especially for the women judges. He feels that there is a need to increase judge per capita to improve the quality and speed of dispensation of justice in the country.

He helped restructure the curriculum at the Punjab Judicial Academy and brought it in line with the global best practices building a sustainable platform for judicial capacity building of the members of the District judiciary and the ministerial court staff. He laid special emphasis on research and played a foundational role in setting up the Lahore High Court Research Centre (LHCRC).

At the Supreme Court of Pakistan, he has helped establish e-courts by video linking the Principal Seat of the Supreme Court with all the Provincial Registries of the Supreme Court, which has helped save travel cost to Islamabad from all over the country and has brought relief to the working schedule of the lawyers who can attend to more cases, work more efficiently by avoiding adjournments. This was done prior to Covid-19 and has attained exceptional utility during the pandemic. The new SC Judicial Mobile Application helps lawyers and litigants navigate their way through the cause lists and court rosters and has enhanced their access to justice. Research and scholarship are the hallmarks of any apex court in the country, hence Research Centre (SCRC) at the SC building was established, manned by bright and promising Civil Judges from all across Pakistan. SCRC carries the vision to eventually provide and support research to all the courts in the country, thereby enriching our jurisprudence and the scholarship of our judges.

Justice Shah is an accredited mediator from CEDR, London; an Honorary Bencher of Lincoln's Inn, UK; a judicial member of the Global Judicial Institute on Environment (GJIE) (Brazil); a member of the Global Constitutionalism (Yale University, 2020- ) and a Member of the Rhodes Scholarship Committee for Pakistan (2019- ). He is an avid golfer, loves sports and enjoys cycling, reading, travelling and music.



#### Ambeng Kandakasi

### Deputy Chief Justice of the Supreme and National Courts of Justice The Independent State of Papua New Guinea

Justice Ambeng Kandakasi was appointed Deputy Chief Justice of the Supreme and National Courts of Justice of Papua New Guinea (PNG) on 13th December 2018. He was appointed a Justice of the same Courts in 2000. His Honour holds a master's degree in Law from the University of San Diego, USA and a Bachelor of Laws degree from the University of PNG. Also, His Honour is accredited as a mediator in Australia, New Zealand and PNG. Before His Honour's appointment, he was a partner of the firm of Young & Williams Lawyers and taught law at the University of PNG.

Presently, His Honour chairs the PNG Judiciary's ADR Committee overseeing the development and successful implementation of court annexed mediation and Alternative Dispute Resolution in PNG. His Honour leads a team of Judges, Magistrates and lawyers designing ADR and mediation systems and structures and implementing them. Mediation is now fully functional. Arbitration Reforms are now being attended to. Through his leadership, the State of PNG has become the 160th country to sign up to the New York Convention on the Recognition and Enforcement of Foreign Arbitral Awards. Also, under his leadership PNG has successfully hosted an international conference on Mediation and Arbitration in March 2019.

He has a passion for continuing legal, judicial, mediation and ADR education and is actively involved in training in these fields. Most of his trainees have been judges, magistrates, senior government and business leaders, lawyers and other professionals, in Solomon Islands, Australia, Fiji, Malaysia and PNG. He has attended and facilitated at a number of local and international workshops and trainings in a number of areas of the law, ADR and in particular mediation. He has published a number of Judgments on mediation and ADR. Further, he has presented and published

several papers at international and local conferences and journals in the areas of mediation and ADR and human rights. His Honour was and continues to be the Vice President of the Perth based, Asia Pacific Mediation Forum.

One of his most recent passion is in the area of environmental law with focus on climate change and greenhouse effect.



#### Suntariya Muanpawong

### Secretary of the Court of Appeal Region I The Kingdom of Thailand

Justice Suntariya Muanpawong is the Secretary of the Court of Appeal Region I. She received Bachelor and Master of Law from Thammasat University, Barrister at Law from Thai Bar Institute and Master and Doctorate Degree in public law from Muenster University, Germany. Before becoming a judge, she was a lawyer, a teacher in a Southeast Asian refugee camp and a legal officer in the Harbor Department. Justice Suntariya was the first supervisor of the Judicial Research Institute, where she played a significant role in developing the accountability and responsiveness of the judiciary. She attended various human rights programs held by international institutions. She has been a proponent of people-oriented justice reform and has conducted many research projects on child rights protection, gender justice, prisoner rights and environmental jurisprudence. She used to be the Secretary of the Environmental Law Division and Deputy Secretary of the Supreme Court. She has joined many commissions and working groups to develop the environmental laws.



#### **Lord Robert Carnwath**

### Former Justice of the Supreme Court The United Kingdom of Great Britain and Northern Ireland

Lord Carnwath retired as a Justice in March 2020 after a distinguished judicial career over 25 years, in which he also served as Chairman of the Law Commission, and Senior President of Tribunals, and which culminated in him spending eight years sitting in the UK Supreme Court and the Judicial Committee of the Privy Council. Although he participated in all aspects of the work of the Supreme Court, his principal areas of expertise have been on issues relating to planning and the environment, property, rating, local government and administrative law. He has given many leading judgments on these subjects (some of which are listed on this profile).

Prior to his appointment to the High Court, he practised at the Bar for 24 years from the predecessor chambers of Landmark Chambers, specialising principally in planning, property and administrative law, taking silk in 1985. Between 1980 and 1985 he served as Junior Counsel to the Inland Revenue, and between 1988 and 1994 as Attorney-General to HRH Prince of Wales.

As a judge he has taken an active interest in advancing understanding of the law of the environment and climate change around the world (since 2005 as a member of a judicial taskforce set up by the UN Environmental Programme), and has spoken at judicial conferences in many parts of the world. In 2005 he was a founder member, and first Secretary General of the EU Forum of Judges for the Environment (EUFJE). He also took a particular interest in the law and legal systems of other Commonwealth jurisdictions and has been a regular speaker at conferences of the Commonwealth Magistrates and Judges Association and the Commonwealth Law Association.

In this country he is Honorary President of the UK Environmental Law Association and of the Planning and Environmental Bar Association. He also has strong academic connections, including Honorary Fellow of Trinity College, Cambridge; Visiting Professor of Oxford University; Honorary Professor of University College London; and Visiting Professor in Practice of the Grantham Research Institute on Climate Change and the Environment at the LSE.

Outside the law, he is a keen amateur musician and he is a former Governor of the Royal Academy of Music (Hon FRAM) and former Chairman of the Britten-Pears Foundation.

Mr. Damien J. Eastman is the Deputy General Counsel in the Office of the General Counsel at the Asian Development Bank (ADB). An Australian national, Mr. Eastman holds a Master of Laws (LL.M) from Harvard Law School, and degrees in Arts (BA) and Law (LL.B, 1st Class Honors) from the University of Sydney and the University of Technology, Sydney. He launched ClientEarth in 2007, sparking fundamental change in the way environmental protections are made and enforced across Europe. Now operating globally, ClientEarth uses advocacy, litigation and research to address the greatest challenges of our time – including nature loss and climate change.

In the years since founding ClientEarth, James has developed an ever-growing team of environmental lawyers following his innovative approach to defend the oceans, protect forests and the people who depend on them, and tackle the climate crisis at its root.

With his leadership, ClientEarth has made air pollution one of the major issues of the day and brought successful actions protecting the health of citizens across Europe. Its work is always built on solid law and science. In 2017, James co-authored a book telling the fascinating story of ClientEarth since it was founded. The book won the judges category in the Business Book of the Year Awards in 2018.

He graduated from Yale, Phi Beta Kappa, magna cum laude, with departmental honours in philosophy. He is a Conservation Fellow of the Zoological Society of London; a fellow of the Ashoka Foundation; Member of the Advisory Committee of the International Coalition for Green Development on China's Belt and Road Initiative; Honorary Professor of Law at the University of Bristol; and Visiting Fellow at Lady Margaret Hall, Oxford.

Dr. Christina Voigt is a renowned expert in international environmental law and professor of law at the University of Oslo. From 2009-2018, she also worked as legal adviser and negotiator for the Government of Norway in the UN climate negotiations.

Professor Voigt is currently co-chair of the Paris Agreement Implementation and Compliance Committee. She is also chair of the Climate Change Specialist Group of the IUCN World Commission on Environmental Law and a member of the IUCN Climate Change Task Force.
