On November 4, 2018, President Xi Jinping announced at the opening ceremony of the first China International Import Expo that a new area will be included into the China (Shanghai) Pilot Free Trade Zone. On August 20, 2019, the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone (the “Lin-gang Special Area”) was officially established.

On November 3, 2019, during an inspection tour in Shanghai, General Secretary Xi Jinping made explicit instructions on the development of the Lin-gang Special Area, urging accelerated efforts to make it “a significant base from which talented people, both at home and abroad, can develop internationally integrated innovation, an important hub for synergies between onshore and offshore business development, an important springboard for enterprises to develop and go global, an important channel to make better use of both domestic and international markets and resources, and an experimental field for participating in international economic governance,” and calling for “targeted institutional innovations and reinforced institutional development to improve the quality of economy”.

On November 12, 2020, General Secretary Xi Jinping pointed out at a grand gathering celebrating the 30th anniversary of the development and opening-up of Shanghai’s Pudong that “the Lin-gang Special Area, a new addition to the China (Shanghai) Pilot Free Trade Zone, must bring its role into better play, benchmark itself against the highest standards and levels, and carry out stress testing at a greater degree in order to usher in breakthroughs in several key areas”.

Profile of the Lin-gang Special Area

The total planned area of the Lin-gang Special Area is 873 km², including the region south to Dazhi River and east to Jinhuigang, Xiaoyangshan Island, and the southern part of Shanghai Pudong International Airport. Under the principle of “overall planning and step-by-step implementation,” the first stage of development (119.5 km²) is carried out in Nanhui New City, Xiaoyangshan Island, the southern part of Shanghai Pudong International Airport, and Lin-gang Equipment Industrial Zone.

Chronology of the Lin-gang Special Area

2019

Aug. 6: The Lin-gang Special Area was officially established after the State Council issued the *Overall Plan for the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone*.

Aug. 20: Li Qiang, Secretary of the CPC Shanghai Municipal Committee, unveiled the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone.

Aug. 23: The Shanghai Lin-gang Integrative Testing and Demonstration Zone for Autonomous and Connected Vehicles officially opened.

Sept. 6: The Breton Lin-gang Technology Center in Lin-gang Fengxian Industrial Park opened.

Sept. 10: The new Vessel Traffic Service (VTS) was unveiled in the Lin-gang Special Area.

Sept. 12: The first batch of key projects of the Lin-gang Special Area was signed and started, involving 23 signed projects, with a total investment of more than 11 billion yuan.

Sept. 16: The international certification agency TÜV Rheinland announced to establish the “Industry 4.0 Engineer Certification and Assessment Center” in the Lin-gang Special Area, the first one of its kind in China.

Sept. 16: Shanghai ZhenGe Biotech Co., Ltd. signed a contract for its commercial production project ap-

proved with GMP certificate of macromolecular bio-pharmaceuticals and cell culture medium to settle in the Lin-gang Special Area.

Sept. 20: The Lin-gang Special Area Administration signed contracts with 16 financial institutions.

Sept. 26: The Lin-gang Special Area witnessed the signing ceremony for new energy & intelligent connected vehicle industry development and key projects to include 24 projects worth a total investment of nearly 8 billion yuan.

Sept. 26: A strategic cooperation agreement with the Hydrogen Energy Industrial Park of the Lin-gang Special Area was signed in Lin-gang.

Sept. 29: The new construction project of S2 Shanghai-Luchaogang Expressway and Haigang Avenue Overpass Ramps kicked off.

Sept. 29: China (Shanghai) Pilot Free Trade Zone Lin-gang Special Area Sub-branch of the China Construction Bank built a cross-border two-way renminbi fund pool for newly established companies in the Lin-gang Special Area.

Oct. 12: The northern part of Lin-gang Satellite Development Base was completed and opened. In the meanwhile, the Micro-satellite Modular Intelligent Manufacturing and Application Innovation Platform, one of the Collaborative Innovation Cross-research Platforms to Build Shanghai into a Science and Technology Innovation Center, broke ground.

Oct. 15: BMW Group's Asian spare parts distribution

centre held an opening ceremony in Yangshan Bonded Port Area of the Lin-gang Special Area.

Oct. 17: Shanghai Branch of the Bank of Communications successfully handled the transfer business of the first bonded warehouse receipt for bulk commodities after the establishment of the Lin-gang Special Area, with a transaction amount of US\$ 4.254 million.

Oct. 18: The Lin-gang Special Area witnessed the key projects signing ceremony for biomedical industry and the inauguration of the Life Science and Technology Industrial Park to include 15 key projects worth a total investment of over 7 billion yuan.

Oct. 19: Shanghai Pudong New Area People's Court set up the China (Shanghai) Pilot Free Trade Zone Court and the Lin-gang Special Area Trial Station of China (Shanghai) Pilot Free Trade Zone Intellectual Property Court.

Oct. 20: The speed upgrade start-up project of Liang-gang Avenue in the Lin-gang Special Area started.

Oct. 20: The World Maritime Conference 2019 under the theme of “New Era, New Technology, New Maritime” was held in the Lin-gang Special Area.

Oct. 22: The key national scientific and technological infrastructure project of high-efficiency and low-carbon gas turbine test device broke ground in the Lin-gang Special Area.

Oct. 25: The Lin-gang Special Area Administration and State Grid Shanghai Municipal Electric Power Company signed a strategic cooperation agreement, and

the Lin-gang Special Area integrated energy workstation was inaugurated.

Oct. 25: The second “New Era • Powerful Shipping Industry • Chinese Dream—Intelligent Shipping and Innovation Development Conference” was held in the Lin-gang Special Area.

Oct. 28: The new construction project of S3 Highway (Zhoudeng Highway—G1503-Lianggang Avenue Interchange) in the Lin-gang Special Area started.

Oct. 29: The 2nd World Laureates Forum was unveiled in the Lin-gang Special Area. China’s President Xi Jinping sent a congratulatory letter to the forum.

Oct. 30: Shanghai Lin-gang Economic Development (Group) Co., Ltd. and China Transport Telecommunication Information Group Co., Ltd. signed a cooperation agreement on China Transport Telecommunication Information and Lin-gang (BeiDou) Science and Technology Industry Cluster, aiming at helping the Chinese BeiDou Navigation Satellite System go global.

Oct. 30: A delegation of the UNESCO Institute for Lifelong Learning visited the Lin-gang Special Area.

Nov. 2: The groundbreaking ceremony of the second phase of Shanghai Mobile International Data Center was held in the Lin-gang Special Area.

Nov. 5: A signing ceremony of cultural cooperation projects between China and France was held at the Consul General of France in Shanghai. The parties concerned will jointly develop and build an “International Cultural Copyright Trading Center” and an “Interna-

tional Cultural Industry Park” in the Lin-gang Special Area.

Nov. 6: The Lin-gang Special Area Administration and Qatar Free Zones Authority (QFZA) signed a memorandum of understanding to further promote the development of their free trade zones.

Nov. 9: SAIC Motor Corporation Limited, Shanghai International Port (Group) Co., Ltd., and China Mobile officially launched the demonstration operation of the world’s first “5G+L4 intelligent-driving heavy truck” in the Lin-gang Special Area.

Nov. 13: Shanghai’s first national-level flying camp was put in operation in the Lin-gang Special Area.

Nov. 20: The Lin-gang Special Area held the launch and signing ceremony of the Lin-gang Special Area International Data Port.

Nov. 21: A Belgian economic mission visited the Lin-gang Special Area to promote practical cooperation between Chinese and Belgian enterprises.

Nov. 28: The Lin-gang Special Area Administration released the *Industrial Map of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone*.

Nov. 28: The Lin-gang Special Area’s terahertz innovation platform was launched.

Dec. 5: The Lin-gang Special Area announced the future development space layout of the downtown area of Lin-gang. Altogether 50 major projects were signed, involving a total investment of 29.5 billion yuan.

Dec. 6: WAIC Developers • Shanghai Lin-gang Ar-

tificial Intelligence Developer Conference under the theme of “Open Source and Opening-up” was held in the Lin-gang Special Area.

Dec. 8: The first “Lin-gang Special Area Investment Forum” under the theme of “New Area · New Industry · New Future” was unveiled in the Lin-gang Special Area.

Dec. 10: The Jade Garden, a phase-I standard factory building of Advanced Intelligence Manufacturing Area in the Lin-gang Special Area, opened, and will be built into an intelligent manufacturing industry base.

Dec. 19: The enterprises to settle in the Marine Cube Park of Lin-gang Marine High-tech Park in the Lin-gang Special Area, collectively signed contracts, and the third phase of the project kicked off.

Dec. 20: Shanghai Mobile Lin-gang Special Area Development Service Center was inaugurated to accelerate

5G planning and construction.

Dec. 24: The Global Cross-border Technology Trade Center and Offshore Incubation Base, and the technology transfer incubation base of Shanghai Newspaper Intelligence Media were inaugurated.

Dec. 28: The first lithography equipment of GTA Semiconductor's special process production line moved into the Lin-gang Special Area.

Dec. 30: The project of Shengmei Semiconductor equipment R&D and manufacturing centre kicked start in the Lin-gang Special Area.

2020

Jan. 7: The made-in-China Tesla Model Y was offi-

cially launched, and the first China-built Model 3 vehicles were delivered to consumers.

Jan. 11: The Lin-gang Special Area held the Conference on Optimizing the Business Environment and Promoting Investment Development & the 2020 Work Conference to deploy the annual tasks for development and construction, and called for optimization of business environment and promotion of investment development.

Jan. 13: The functional projects of the Lin-gang Special Area were collectively signed, with a total investment of nearly 20 billion yuan to cover supporting urban functions such as commerce, culture, tourism, and sports.

Feb. 18: The first oil drilling platform produced in Shanghai in 2020 was delivered abroad in the Lin-gang Special Area.

Feb. 22: The Lin-gang Special Area launched China's first government-built "Service Platform of Shared Employees," taking the lead in resuming work and production.

Feb. 27: Shanghai Branch of the Bank of China took the lead in providing facilitation services for cross-border renminbi settlement for companies in the Lin-gang Special Area.

Mar. 5: GalaxyCore (Hong Kong) Inc. signed a co-operation agreement with the Lin-gang Special Area Administration and Lin-gang Group, planning to invest in the Lin-gang Special Area to develop the "special

process R&D and industrialization project of 12-inch CIS integrated circuit,” with an investment of approximately US\$ 2.2 billion

Mar. 9: The Lin-gang Special Area released the *Implementation Plan of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone for Comprehensively Deepening the Construction of a World-class Business Environment*, and planned to fully implement unique business environment indicators.

Mar. 18: The phase III standard factory building (Intelligent Chip Valley) at Shanghai Minlian Lin-gang Park in the Lin-gang Special Area started construction.

Mar. 26: The Lin-gang Special Area Administration for Market Regulation was unveiled. On that day, six companies became the first ones to be awarded licenses by the Lin-gang Special Area Administration for Market Regulation, and two companies were awarded business licenses.

Mar. 31: The pilot scheme for cross-border transfer business of domestic trade financing assets was launched in the Lin-gang Special Area to give play to the role of financial reform in leading innovation and the pioneering role of financial opening-up.

Apr. 2: The Lin-gang Special Area Administration and China Ping An Insurance signed a strategic cooperation framework agreement. The two parties will carry out in-depth cooperation in the fields of finance, smart cities, and urban development and construction.

Apr. 2: The Public Security Office of the Lin-gang

Special Area was inaugurated.

Apr. 20: The Lin-gang Special Area Office of Shanghai Communications Administration was officially unveiled and put into operation, and the *Special Planning of Communication Infrastructure for the Lin-gang Special Area (2020-2025)* was released.

Apr. 20: The Lin-gang Special Area Administration and Shenergy Group signed a strategic cooperation framework agreement to carry out in-depth cooperation in building gas infrastructure and service standards, developing hydrogen energy infrastructure and industries, constructing and operating integrated energy projects in the Lin-gang Special Area, and improving its financial service.

Apr. 27: The freezer (cold storage) warehouse project for customs inspection in the clearance area of Yangshan Port in the Lin-gang Special Area kicked off.

Apr. 30: The Lin-gang Special Area Intellectual Property Protection Center of Shanghai People's Procuratorate was inaugurated.

May 16: The first full-function cross-border two-way renminbi fund pool in the Lin-gang Special Area was officially launched.

May 16: Yangshan Free Trade Zone was officially inaugurated, becoming the only special comprehensive bonded zone among 151 areas under special customs supervision in China, and the first batch of 18 projects was signed.

May 20: The Lianggang Avenue (S2-Dazhi River)

speed upgrade project started, with a total length of about 12.8 km and a total investment of 2.345 billion yuan.

May 20: The Lin-gang Special Area Office of Shanghai Maritime Safety Administration was unveiled. A total of 36 administrative law enforcement powers of devolution were adjusted to enable Lin-gang's maritime business to be dealt within the area.

May 29: The administrative law enforcement agencies and affiliated institutions of the Lin-gang Special Area Administration were unveiled, and the original 14 units were integrated into 9.

Jun. 1: The “Information Flying Fish” global digital economy innovation island was launched, for more than 100 leading enterprises, enterprises with characteristics, and industry institutions to jointly build an information industry alliance in the new area.

Jun. 11: The Lin-gang Special Area Administration and China United Gas Turbine Technology Co., Ltd. signed a strategic cooperation agreement.

Jun. 18: Four ecological environment projects in the Lin-gang Special Area, including the Lin-gang Water Plant and the second phase expansion of Lin-gang Sewage Plant, kicked off construction.

Jun. 23-Jul. 22: A draft plan entitled the *Master Plan for Territorial Space of China (Shanghai) Pilot Free Trade Zone Lin-gang Special Area (2019-2035)* was released to the public.

Jun. 30: GTA Semiconductor's special technology

production line in the Lin-gang Special Area was officially put in operation.

Jul. 7: The Lin-gang Special Area's key industrial projects in 2020 started in batches, with a total investment of about 48 billion yuan. Li Qiang, Secretary of the CPC Shanghai Municipal Committee, attended the kick-off ceremony and announced the start of the projects. Gong Zheng, Mayor and Deputy Secretary of the CPC Shanghai Municipal Committee, delivered a speech.

Jul. 24: China-Japan (Shanghai) Local Development Cooperation Demonstration Zone was inaugurated in the Lin-gang Special Area, becoming one of the six China-Japan local development cooperation demonstration zones across the country.

Jul. 30: The Tourism Alliance Salon of the Lin-gang Special Area was inaugurated, and the first batch of “Lin-gang Smart Tourism”—industrial tour routes was launched.

Jul. 31: The Lin-gang Branch of Industrial Securities, the first brokerage in the Lin-gang Special Area, held its inauguration ceremony.

Aug. 13: Shanghai Municipal People's Government held a press conference to brief on the reform and innovation of the Lin-gang Special Area on its first anniversary.

Aug. 13: Shanghai Natural Resources Title Confirmation and Registration Service Center established a special service office for enterprises in the Lin-gang

Special Area.

Aug. 18: Construction of Dishui Lake Station on the medium-traffic T1 Demonstration Line in the Lin-gang Special Area started.

Aug. 18: The Lin-gang Special Area International Talent Service Hub officially opened.

Aug. 19: China's first 12-inch automotive-grade power semiconductor automated wafer manufacturing centre project was signed and settled in the Lin-gang Special Area, with a total investment of 12 billion yuan, and an annual production capacity of 360,000 wafers after reaching the target output.

Aug. 20: Dishui Lake Financial Bay broke ground. The project is located in an open area for the modern service industry on the true north side of Dishui Lake in the Lin-gang Special Area. It covers a total area of 442 mu and a total building area of 1.48 million m^2 .

Aug. 20: The new construction project and six large- and medium-scale repair projects of the Y4 Road (Dalu Line—Lin-gang Avenue), the north-south arterial road of the Lin-gang Special Area, started collectively, with a total investment of approximately 2.05 billion yuan.

Aug. 21: A total of 16 key fund projects for 2020 were signed in batches in the Lin-gang Special Area, with a total investment of more than 84.2 billion yuan.

Aug. 21: The opening ceremony of Lin-gang Summit for CEOs of leading companies in the integrated circuit industry was held in the Lin-gang Special Area.

Aug. 28: A large-scale biopharmaceutical CDMO

(Contract Development and Manufacturing Organization) integrated platform project of BiBo Pharma Scientific Co., Ltd. with an investment of nearly 2 billion yuan settled in Life Science Blue Bay in the Lin-gang Special Area.

Aug. 28: The Overseas Students Pioneer Park in the Lin-gang Special Area was unveiled.

Sept. 8: Investment Technology League (ITL) was inaugurated in the Lin-gang Special Area.

Sept. 10: Life Science Blue Bay Biomedical Industrial Park in the Lin-gang Special Area officially opened. More than 20 high-level industrial projects were signed, with a total investment of 16 billion yuan.

Sept. 16: The automotive AI chip global R&D centre project with an investment of nearly 3 billion yuan settled in the international innovation collaboration zone of the Lin-gang Special Area.

Sept. 24: Shanghai Municipal People's Government held a press conference to release the *Lin-gang Special Area Innovative Industry Plan*, aiming at building a world-class, open and modern industrial system with high quality.

Sept. 25: The first non-cross-reactive antibody factory in China was officially put into production in Life Science Blue Bay in the Lin-gang Special Area.

Sept. 28: The projects of supporting industries of new energy vehicles for 2020 were collectively signed in the Lin-gang Special Area, and the projects of 13 key enterprises settled here, with a total investment of more

than 4 billion yuan, and an estimated output value of more than 10 billion yuan.

Sept. 30: The Huanhu Road No. 1 Demonstration Line in the Lin-gang Special Area for intelligent connected buses and intelligent road tests started testing.

Oct. 13: The Lin-gang Special Area and Shanghai Services Federation signed a strategic cooperation on a number of key service industry projects to jointly promote the high-quality development of modern service industry.

Oct. 15: CAFA and Kedge Business School jointly set up the Franco-Chinese Institute of Arts and Design Management in the Lin-gang Special Area.

Oct. 16: The first China-made six-inch silicon carbide MOSFET (*Metal-Oxide-Semiconductor Field-Effect Transistor*) wafer was released.

Oct. 23: Shanghai Aviation and Aerospace Industry Characteristic Park was licensed, and the Large Aircraft Industrial Park in the Lin-gang Special Area was launched. A total of 22 projects were signed to settle in the Large Aircraft Industrial Park, with an estimated total investment of over 20 billion yuan. At the same time, the construction of “One Valley and One Park in the Large Aircraft Industrial Park in the Lin-gang Special Area” also started.

Oct. 23: The high-temperature-resistant continuous alumina fiber preparation project of Shanghai Rongrong New Material Technology Co., Ltd. with an investment of 350 million yuan settled in the Lin-gang Special Area.

Oct. 23-24: The first “1024 International Investment Technology Developer Conference” centred on “data technology” was held in the Lin-gang Special Area.

Oct. 26: Tesla Giga Shanghai started to export its made-in-China electric vehicles.

Oct. 27: The Lin-gang Special Area “Oriental IC Port” comprehensive integrated circuits (IC) industrial base was inaugurated. A total of 14 key projects were signed, with a total investment of 22.5 billion yuan.

Oct. 30: The Third World Laureates Forum kicked off, and the World Laureates Community broke ground, with a planned area of 2.5 km² stretching from Nangang Avenue in the east to Haigang Avenue in the west, and from Haiji Road No. 1 in the south to South Huanhu Road No. 3 in the north.

Nov. 7: During the 3rd China International Import Expo, Novo Nordisk, a leading biopharmaceutical company in the world, and the Lin-gang Special Area Administration signed a strategic cooperation framework agreement, involving a total investment of 200 million yuan.

Nov. 11: The International Designer Creation Camp was unveiled in the Lin-gang Special Area.

Nov. 12: The celebration of the 30th anniversary of Pudong’s development and opening-up was held. Xi Jinping, General Secretary of the CPC Central Committee, President of China, and Chairman of the CPC Central Military Commission attended and delivered an important speech. He pointed out that the Lin-gang

Special Area should give better play to its role, align with the highest standards and levels, implement greater stress testing, and take the lead in achieving breakthroughs in several key areas.

Nov. 13: The Shanghai Municipal People's Government released the *Implementation Plan for the Pilot Program of Comprehensively Deepening the Innovation and Development of Trade in Services in Shanghai (2020)*, proposing to conduct pilot projects on the establishment of an account system that integrates local and foreign currencies in the Lin-gang Special Area.

Special Location Advantages

The Lin-gang Special Area is located at the southeast corner of Shanghai, with Pudong International Airport, the third largest airport in the world, at its north, and Yangshan Deep Water Port, the largest container port in the world, at its south.

As an independent node city of the Yangtze River Delta, it sits at the northern end of Hangzhou Bay, a major passage over the sea, and the middle-section of coastal corridor of east China.

The total planned area of the Lin-gang Special Area is 873 km², including the region south to Dazhi River and east to Jinhuigang, Xiaoyangshan Island, and the

southern part of Pudong International Airport. Under the principle of “overall planning and step-by-step implementation,” the first stage of development (119.5 km²) is carried out in Nanhui New Town, Xiaoyangshan Island, the southern part to Pudong International Airport, and Lin-gang Equipment Industrial Zone.

The Lin-gang Special Area sits at the intersection of the Yangtze River estuary and Hangzhou Bay, connecting Pudong International Airport, the third largest airport in the world, in the north and Yangshan Deepwater Port, the largest container port in the world, in the south. It also boasts the only multi-purpose port in southeast Shanghai—Shanghai South Port. It is a critical link along the coast combining sea, land, air, rail, underground and river transport, and an international frontier urban area that faces the world, connects Asia-Pacific and serves the Yangtze River Delta.

Sea Transport: With Yangshan Deep Water Port and Shanghai South Port in its vicinity, Lin-gang Special Area is only 35 km to Yangshan.

Air Transport: With Pudong International Air Transport Hub at its north, it takes only 15 minutes to get to Pudong Airport and 60 minutes to Hongqiao Airport from downtown Lin-gang.

Road Transport: The total road network stretches 1,500 km, among which 71 km are expressway. A 150-km rapid road network and a 400-km arterial highway network are planned. It takes less than 30 minutes on


average to go to any place in downtown Lin-gang.


Metro Transport: It takes 37 minutes from Longyang Road Station (Metro Line 16) to Lin-gang Special Area. A 100-km transport framework is planned, which takes only 30 minutes to downtown Shanghai.

Rail Transport: Pudong Railway is now used for freight transportation, but it will be upgraded to an intercity railway connecting directly to Shanghai South Railway Station. It is integrated into the Yangtze River Delta and reaches nearby cities in the delta in 90 minutes.

River Transport: There are Dalu Line (level 3 passage) and Jinhuigang (level 4 passage).

By 2022, Lin-gang Special Area issued the *Three-Year Action Plan for the Improvement of Transport in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone (2020-2022)* on April 18, 2020, which aims to further ameliorate Lin-gang's connectivity to other areas as well as its internal transport network.





Local level: Build multi-level and green transport corridor. Improve the smooth transit among areas in Lin-gang to offer more choices on transport routes.

Municipal level: Improve the capacity and quality of transport corridors. Form an intensive rapid road system connecting the center of Lin-gang to key areas and transport hubs in Shanghai.

Internal level: Provide easy, smart and intensive service. Ensure the connectivity among the functional areas in downtown Lin-gang. Embody the features of transport in the Lin-gang Special Area.

By 2035, build a modern, multimodal and comprehensive transport system in four dimensions, namely on global, national, regional (Yangtze River Delta), municipal and local levels. Achieve the “15-30-60-90” transport service goal, which means 15 minutes to Pudong International Airport, 30 minutes to Longyang Road Hub in downtown Shanghai, 60 minutes to Hongqiao Airport, 90 minutes to nearby cities in the Yangtze River Delta.

Special Industrial Foundation

After 18 years of preliminary development, the Lin-gang Special Area has laid a solid industrial foundation, initially become home to several key enterprises in the fields of new energy equipment, marine engineering, intelligent manufacturing, biomedicine, and AI, etc., gathered a cluster of industry leaders from home and abroad, achieved a series of major national technological breakthroughs, and contributed numerous technologies and products that are No.1 in China and even the world.

On May 10, 2018, Tesla (Shanghai) Co., Ltd. was established, and on October 17 of the same year, Tesla (Shanghai) Co., Ltd. won the long-term lease for land in Lin-gang. On January 7, 2019, the first phase of the Tesla Giga Shanghai broke ground, and was completed and fully put into operation ten months later. Tesla Giga Shanghai is the largest foreign-invested manufacturing

project in Shanghai to date and the first Gigafactory of Tesla outside of the United States.

The Lenze Group is headquartered in Germany and currently has more than 3,000 employees worldwide. For more than 60 years, drive and automation systems have been the core competitiveness of Lenze, making it one of the most innovative companies in the industry. In 2007, the Lenze Group established a wholly-owned subsidiary, Lenze Drive Systems (Shanghai) Co., Ltd., in Shanghai, China. At present, the company has established a production base and a logistics centre in the Lin-gang Special Area, and set up sales offices in 12 cities across the country to respond to the needs of the Chinese market in time.

MAN Group, based in Germany, is a Fortune 500 company and one of the world's leading manufacturers of trucks, buses, and diesel engines. MAN is a subsidiary



of Volkswagen (China) Investment Co., Ltd., and is mainly engaged in the sales and after-sales services of steam turbines, turbo compressors, generator sets, and other products and mechanical parts. MAN China is a headquarter economy enterprise in the Lin-gang Special Area, managing the business activities of MAN Group in the Asia-Pacific region.

Special Urban Planning

As a typical seaport city, Lin-gang is nestled by the sea and prospers due to its geographical location. In 2002, a German architecture firm named gmp Architekten participated in the planning and design of Lin-gang, and came up with a concept that is both classic and stylish: Ripples spread out after a drop of water falls from the sky, forming multiple urban belts with different

functions. Based on this planning, Lin-gang has gradually begun to develop and prosper.

The International Innovation Collaboration Zone has a planned area of about 10.3 km². The area is composed of the Science and Technology Innovation City Community, the World Laureates Community, the Science and Technology Innovation Headquarters Bay,

and the Future City. Eight functional platforms have been formed, including a functional platform for intelligent manufacturing R&D and commercialization, a functional platform for industrial Internet R&D and commercialization, an AI Industry Base in Lin-gang, Shanghai Zhuguangya Institute of Advanced Science and Technology, Undersea Science Observation Center of Tongji University, Comprehensive Demonstration Area of Land, Sea and Air Vehicles Unmanned System in the Lin-gang Special Area, Tsinghua University Smart Skynet Innovation Project, and Fudan Lin-gang Industrialization Innovation Platform. Meanwhile, in the International Innovation Collaboration Zone, six industries including artificial intelligence, industrial Internet, integrated circuits, intelligent connected vehicle, civil aviation, and intelligent manufacturing have been

thriving.

Located in the main urban area of Lin-gang, Shanghai, the Modern Service Industry Open Zone makes full use of Shanghai's resource endowments and open-up advantages, incorporating its own functional positioning to continuously improve the industrial system and industrial development space. With finance as its core, it develops new forms of modern services in an all-round way, strives to promote financial innovation and pilot projects, expands cross-border financial service functions, promotes offshore business development, enhances the headquarters economy, and develops new international trade to create a new pace-setter of the modern service industry.

According to the construction requirements of "global coordination, regional interaction, ecological soundness

and livability, and high-end clusters,” the Modern Service Open Zone, with a planned area of 19.67 km², will construct a spatial layout of “one island + five zones,” including the culture and art island, the financial innovation functional zone, the central business district, the cross-border international trade and international community, the international information industry cluster zone, and the supporting industrial service zone.

Special Comprehensive Bonded Zone

On May 16, 2020, Yangshan Free Trade Zone was officially inaugurated, becoming the only special comprehensive bonded zone among 151 areas under special customs supervision in China. It has a planned area of 25.31 km², including Luchaogang Port area, Xiaoyangshan Island area, and the southern part of Pudong Inter-

national Airport.

Yangshan Free Trade Zone puts in place a regulatory framework for trade facilitation and liberation with international competitiveness. Overseas goods entering the zone shall be bonded or exempted from tax; goods exiting the zone and sold in areas other than the zone in the territory of China shall be subject to customs declaration according to the relevant provisions on import of goods; and goods outside the zone in the territory of China shall be deemed export and be subject to tax exemption when entering the zone. The VAT and consumption taxes shall not be imposed on the transactions of goods between the enterprises in the zone. In the first line, the goods that do not involve document verification or inspection shall be directly released by the Customs, and in the second line, the supervision documents will be verified. The goods in the zone will be exempted from regular customs supervision such as bonded account book management, write-off, and administration of unit consumption in the special customs supervision area. For goods entering and exiting the second line, the double-sided declaration system for enterprises inside and outside the zone will be changed to unilateral declaration by enterprises outside the zone; and a special customs statistics method shall be implemented. Enterprises in the zone can carry out logistics and warehousing, transit and consolidation, display transactions, distribution and delivery, R&D and manufacturing, inspection, maintenance and remanufacturing by law.

Leading Science & Technology Industry Integrated Circuit

Brief introduction: The integrated circuit industry in the Lin-gang Special Area starts from the development of equipment and material industries, with its industrial chain continuously expanding and upgrading. By the end of 2020, the Lin-gang Special Area had introduced more than 40 industry benchmark companies. An ecosystem of the whole integrated circuit industry chain covering chip design, special process manufacturing, new storage, third-generation semiconductors, IC packaging and testing, equipment, materials, and other links has initially taken shape.

In the future, the Lin-gang Special Area will focus on the core of the integrated circuit industry chain, promote breakthroughs in the whole industry chain, and build a national-level comprehensive integrated circuits

(IC) industrial base and a core industry cluster with global influence.

Oriental IC Port: Covering a planned area of 10 km², the “Oriental IC Port” in the Lin-gang Special Area is one of the 26 characteristic industrial parks in Shanghai, and is growing into a future-oriented strategic supporting area and an emerging growth pole for the integrated circuit industry in Shanghai. The park will focus on core chips, special processes, key equipment, and basic materials to achieve core technology

breakthroughs and build a national-level comprehensive integrated circuits (IC) industrial base. The park is expected to reach a production volume of 100 billion yuan in 2025, and a high-level industrial ecosystem will be created in 2035, making the park a real “Oriental IC Port” with global influence.

Support policies: *Several Measures for the Concentrated Development of the Integrated Circuit Industry in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* has been released to outline ten measures for the concentrated development of the integrated circuit industry, including the support for the prior planning of major projects, support for problem tackling in core technologies and products, support for large-scale development of enterprises and providing all-round support to project construction, scale development, corporate mergers and acquisitions, equipment purchases, R&D investment, EDA/IP purchases, and tape-out by enterprises of integrated circuit companies.

Biomedicine

Brief introduction: The biomedical industry is a strategic emerging industry to which the Lin-gang Special Area gives priority. The Lin-gang Special Area focuses on promoting the construction of an international medical service cluster, and will create a development environment with the most concentrated elements and resources, the most complete system and functions, and the most active market participants for the innovative

development of the biomedical industry by taking advantage of high-level freedom and openness, pioneering support policies and visible increase in benefits.

As of the end of 2020, the Lin-gang Special Area had gathered more than 80 biomedical companies in 15 fields, with leading companies in each field.

In the future, the Lin-gang Special Area will aspire to stay ahead in the global biomedicine and life & health industries and focus on the R&D of novel drugs and high-end medical devices to create an internationally competitive biomedical R&D and manufacturing base and service centre.

Life Science Blue Bay: It is located in the Lin-gang Special Area, and is one of the 26 characteristic industrial parks in Shanghai. Covering a planned area of 4.5 km² for the first phase, Life Science Blue Bay covers three major sectors, namely biomedicine, high-end medical equipment, and international medical services, and integrates functions such as “R&D, production, testing, and display” in the four primary industry sectors, 12 secondary sub-industries and 33 sub-sectors of precision diagnosis, precision medicine, precision surgery, and health-related extended services. By 2025, it is planned to gather about 100 high-end enterprises in the industry, including two ten-billion-level enterprises, five billion-level enterprises, and two high-end hospitals, making the total output value of the life science and technology industry exceed 30 billion yuan. By 2035, the park is planned to gather about 200 high-end

enterprises in the industry, expand the scope of services to cover derivative fields such as health care, aesthetic medicine, education, and training with the life science and technology industry as its core, and build a big health service industry system with a total output value exceeding 100 billion yuan.

Support policies: *Several Measures for the Concentrated Development of the Biomedicine Industry in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* has been released to outline ten measures

for the concentrated development of the biomedical industry, including the support for major projects, support for scale-up development of enterprises, support for enterprises to explore markets, support for professional services, and support for improvement in R&D capability of novel drugs, so as to build a complete life science and technology industry chain, meet the needs for the industrial application of high-end biomedical R&D projects, and support domestic and industrial preparation projects that fill the gaps in China.

Civil Aviation

Brief introduction: Upon the establishment of the Lin-gang Special Area, an overall development plan for a 24.7-km² aviation industrial park, which is located in the southern part of Shanghai Pudong International Airport, was proposed. According to the plan, the area will be developed into a world-leading cluster of cutting-edge emerging industries with global influence and innovation power, with the aviation industry as its core.

By the end of 2020, a number of leading enterprises and scientific research institutions in the aircraft manufacturing field had settled in the Lin-gang Special Area, covering new aviation materials, airborne equipment, environmental control, maintenance and modification, aviation services, and other aviation industry clusters.

In the future, the Lin-gang Special Area will create a civil aviation industry system integrating design, R&D, manufacturing, application, and service, build a com-

petitive and influential civil aviation industry cluster, and actively develop the aerospace industry.

The Large Aircraft Industrial Park: Located in the Lin-gang Special Area, it is one of the 26 characteristic industrial parks in Shanghai, with the area in the southern part of Shanghai Pudong International Airport as the core supporting area. The planned area is 24.7 km², which includes the 7.86-km² Yangshan Free Trade Zone, China's only special comprehensive bonded zone. The industrial park has an airport and expressways such as G1503, S32, and S1, planning to complete a “land, sea, air, and rail” multimodal transportation system. Based on the existing industrial layout in the Lin-gang Special Area of COMAC and AECC, two giants in China's civil aviation industry, the Large Aircraft Industrial Park will lead the aviation industry in the Lin-gang Special Area to achieve an overall layout and full-chain development.

The Lin-gang Special Area will combine high-quality industrial resources from home and abroad to accelerate the construction of a special technological innovation system for large passenger aircraft. Meanwhile, the “7+2” aviation manufacturing industry cluster will be developed around the final assembly of large passenger aircraft to achieve interconnected development inside and outside Lin-gang Special Area. Around the airside, the park will develop a one-stop platform for international aviation productive services, coordinate onshore and offshore businesses, focus on the development of high-end aviation services, and create the world’s only world-class aviation industry cluster featuring “integration of aviation manufacturing + aviation service”.

Support policies: *Several Measures for the Concentrated Development of the Aviation and Aerospace Industry in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* has been released to outline

ten measures for the concentrated development of the aviation and aerospace industry, including the support for global coordinated layout of major projects, support for the R&D of core technologies and products, support for the development of the whole industry chain and the construction of industrial clusters, and support for the expansion of transactions and purchases in the Lin-gang Special Area. These measures serve as support in building the Lin-gang Special Area into a world-leading cluster of cutting-edge emerging industries with global influence and innovation power, and with the aviation industry as its core.

Artificial Intelligence

Brief introduction: The Lin-gang Special Area is the main supporting area for building Shanghai into a scientific and technological innovation centre with global influence. Currently, it is vigorously pushing ahead with the plan of building Shanghai into an intelligent manufacturing centre with global influence.

By the end of 2020, thanks to solid industrial foundations such as intelligent manufacturing and industrial Internet construction, the Lin-gang Special Area had pooled a number of AI technology R&D platforms and benchmarking enterprises, covering hardware, algorithms, applications, and other critical aspects.

In the future, driven by innovation of core AI technologies and underpinned by diversified application scenarios, the Lin-gang Special Area will combine

international innovation elements, promote the development and demonstration of in-depth integration of AI and the real economy, and build a demonstration area for AI innovative applications.

Support policies: *Several Measures for the Concentrated Development of the Artificial Intelligence Industry in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* has been released to outline ten measures for the concentrated development of the AI industry, including the support for the aggregation of major projects, support for original innovation in key technologies, and support for rich scenarios to realize pilot application. With these measures, the AI industry will be enabled to serve as an impetus to develop new industries and new business forms such as intelligent connected vehicles, intelligent manufacturing, and intelligent robots.

New Energy & Intelligent Vehicles

Brief introduction: The new energy & intelligent connected vehicles constitute an important part in the planning and development of the Lin-gang Special Area. The development of the new energy vehicle industry has been viewed by the Lin-gang Special Area as a national strategy. Backed by top companies such as Tesla and SAIC Roewe, the Lin-gang Special Area has been focusing on the investment promotion in both upstream and downstream of the industrial chain, and actively negotiating with a large number of enterprises, basically forming a benign development pattern in which our self-owned brands, top foreign brands and new manufacturers flourish together, the production capacity of completed projects continues to rise, the projects under construction pick up speed, and projects in the pipeline speed up site selection. A world-class new energy automobile industry cluster is in the making.

As of the end of 2020, the Lin-gang Special Area had gathered three factories of finished vehicles, as well as industry-leading automobile supporting enterprises. In terms of technological innovation and industrialization of intelligent connected vehicles, the Lin-gang Special Area has established the Shanghai Lin-gang Integrative Testing and Demonstration Zone for Autonomous and Connected Vehicles to have an area of 7 km² for closed test and experience of unmanned intelligent connected vehicles. The first phase of the open roads for unmanned automatic driving tests in the integrative

testing and demonstration zone boasts a length of 26.1 km, which can fully simulate the traffic environment of “highway + city + countryside + logistics + warehousing”. In terms of the logistics infrastructure for finished vehicle trade, the Lin-gang Modern Logistics Park and the land part of Yangshan Bonded Port Area have gathered the Asia-Pacific distribution centres of well-known car makers such as BMW, Volkswagen, and Porsche, as well as many shipping, logistics, and trade service companies including Maersk.

In the future, the Lin-gang Special Area will build a new energy & intelligent vehicle industrial ecosystem featuring transboundary integration, form a new energy & intelligent vehicle industry cluster and application demonstration zone, and become an important growth pole for Shanghai to build a world-class automotive industry centre.

Support policies: The Lin-gang Special Area plays a key role in Shanghai’s efforts to build a world-class automotive industry cluster. *Several Opinions on Promoting the High-quality Development of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone and Implementing Special Support Policies (“50 Policies”)* explicitly puts forward a series of powerful measures, such as supporting those projects in the field of new energy and intelligent connected vehicles, prioritizing the platform arrangements, as well as offering support for IPO financing and equity investment.

High-end Equipment Manufacturing

Brief introduction: Focusing on “high-end and independent manufacturing,” Lin-gang has formed a “6+1” industrial system to combine new energy equipment, automobile vehicles and parts, key ship parts, marine engineering, construction machinery, civil aviation supporting facilities and strategic emerging industries. As one of the two core areas for Shanghai to develop the marine economy, Lin-gang has been focusing on high-end equipment manufacturing and other fields, including marine drilling equipment, and emerging deep-sea industries.

As of the end of 2020, the Lin-gang Special Area had gathered a group of high-end equipment representative enterprises. In total, 11 large central state-owned enterprises, scientific research institutes, and industry leaders

had settled in Lin-gang while large scientific devices had also been installed here. The above players will advance the process of industrialization, promote in-depth industrial coordination, improve the industrial ecology, and create clusters of emerging industries.

In the future, led by intelligent manufacturing and drawing on advantages of the equipment manufacturing industry aggregation, the Lin-gang Special Area will focus on high-end equipment manufacturing, expanding services, precision upgrades, and intelligent upgrades to create a world-class intelligent manufacturing industry centre.

Support policies: It is clearly stated in *Several Opinions on Promoting the High-quality Development of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone and Implementing Special Support Policies (“50 Policies”)* that the Lin-gang Special Area will give top priority to key projects in intelligent manufacturing, high-end equipment, and other fields. Critical functional support platforms, such as engineering research centres and key laboratories, will be set up in the Lin-gang Special Area. Key scientific research institutes, R&D institutions, standards developing enterprises, inspection & testing institutions, and measurement & testing platforms, among others, in related fields shall be encouraged to cluster in the Lin-gang Special Area. Enterprises will receive supports to unite with research institutes and upstream and downstream players of the industry to co-build an industry-coordinated innovation

community and develop an industry-based innovation centre.

Green Remanufacturing

Incumbent enterprises: In 2012, China's first remanufacturing industrial park featuring concentrated development settled in Lin-gang, and a national-level remanufacturing industrial base has been built on this basis. According to the *Overall Plan for the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone*, a maintenance and green remanufacturing centre for countries and regions along the “Belt and Road” shall be built; a green certification and rating system shall be established; the maintenance and remanufacturing of inbound products such as numerically-controlled machine tools and engineering equipment in Yangshan Free Trade Zone shall be supported; and the international competitiveness of the high-end intelligent remanufacturing industry shall be enhanced.

As of the end of 2020, the Lin-gang Special Area had attracted a cluster of representative remanufacturing enterprises. In addition to providing basic services such as factory buildings, logistics services, policy services, and talent services, the Lin-gang Special Area also provides professional services such as raw material supply support, authoritative quality inspection services, technical support, centralized pre-cleaning, and solid hazardous waste treatment.

In the future, the Lin-gang Special Area will put

green manufacturing in place, promote green development, improve the level of circular economy development, and create a remanufacturing innovation demonstration zone at the national level and a high-end green remanufacturing centre for countries and regions along the “Belt and Road”.

Support policies: Support policies are put in place to encourage the concentrated development of the remanufacturing industry. The players may carry out their remanufacturing business by following bonded policies. On the other hand, the facilitation measures for inspection, quarantine, and customs clearance will be applied to the inbound remanufacturing industry in the Lin-gang Special Area.

Modern Service Industry

New-type International Trade

Policies: Given the concentrated development of New-type international trade forms, *Several Measures of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone for Supporting the Innovative Development of the Financial Industry*, *Several Measures for Comprehensively Promoting the Financial Opening-up and Innovative Development of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone*, and *Opinions on Further Accelerating the Construction of Shanghai as a Financial Center with Global Influence and Providing Financial Support for the Integrated Development of the Yangtze River Delta Region* were

formulated after research and study. Some pioneering innovative measures such as the pilot reform of foreign debt registration have been developed and put into trial operation to attract high-quality enterprises and top talent through functional policies, fiscal and taxation policies, and comprehensive support policies.

Planning: To vigorously develop new-type international trade such as offshore trade, cross-border e-commerce, and digital trade, and create an Asia-Pacific supply chain management centre and a new pace-setter for service trade with the help of high-level trade liberalization in the Lin-gang Special Area.

Cross-border Finance

Policies: In view of the concentrated development of new business forms of cross-border finance, *Several Measures of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone for Supporting the Innovative Development of the Financial Industry, Se-*

veral Measures for Comprehensively Promoting the Financial Opening-up and Innovative Development of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone, and Opinions on Further Accelerating the Construction of Shanghai as a Financial Center with Global Influence and Providing Financial Support for the Integrated Development of the Yangtze River Delta Region were formulated after research and study. Some pioneering innovative measures such as the facilitation of cross-border RMB settlement by high-quality enterprises and the cross-border transfer of domestic trade financing assets have been put into trial operation. The “2+X” modern service industry system focusing on cross-border finance and new-type international trade has been gradually formed.

Planning: To keep in line with international standards, promote innovation in financial systems, business and products, vigorously improve cross-border financial service capabilities, orderly explore capital ac-

count opening, and create an innovation pilot zone for financial opening and an international financial service zone with strong influence.

High-level Shipping

Policies: According to the *Overall Plan for the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone*, the Lin-gang Special Area will implement highly open international transportation management; the function of the global pivot port shall be improved, and a global high-level shipping hub will be built; the development of finance lease business in relation to aircrafts, ships, and the like shall be accelerated. The *Opinions on Further Accelerating the Construction of Shanghai as a Financial Center with Global Influence and Providing Financial Support for the Integrated Development of the Yangtze River Delta Region* also clarifies that financial institutions are encouraged to provide long-term credit funds for the development of high-tech industries, shipping industry, and other key fields in the Lin-gang Special Area pursuant to market principles, and support major scientific and technological innovation and R&D projects in the Lin-gang Special Area.

Planning: To expand and upgrade the function as a global pivot port for sea and air transportation, build a regional aviation headquarters base and an international leading shipping logistics centre, and enhance the resource allocation capabilities in global shipping and shipping service functions.

Information Service

“Information Flying Fish” Global Digital Economy

Innovation Island: It is a park specially designed around the theme of information industry, with a total building area of 100 hectares. It is bordered by the World Laureates Community in the east, S2 Shanghai-Luchaogang Expressway and Donghai Bridge in the west, Hangzhou Bay in the south and Chenghe Port in the north. The park will provide spaces for joint investment, operation, R&D, office, production and living for outstanding enterprises, new and dynamic institutions and individuals in the field of digital economy all over the world.

Planning: To keep in line with internationally accepted rules, establish a safe and efficient cross-border data flow system, create a “connector” for openness and

cooperation in the software and information service industry, and build an international hub port on the “Data Silk Road”.

Scientific and Technological Innovation Services

Policies: The *Measures for Managing for Technology Innovation Platforms in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone (For Trial Implementation)*, *Special Implementation Rules for High-tech Industries and Technological Innovation in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone (2020)*, and *Several Policies on Improving the Construction of Scientific and Technological Innovation Capability in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* have been issued based on the research and study of scientific and technological innovation services to enhance the capabilities of scientific and technological innovation and industrial integration, and accelerate the development of high-tech industries and scientific and technological innovation service industries.

Business, Culture, Sports, and Tourism

Policies: To promote the business clustering and sustainable development in the Lin-gang Special Area, *Several Policies for Promoting Commercial Development in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* was formulated after research and study. According to the document, the development

of farmers' markets and basic business facilities in communities shall be supported to meet residents' daily needs and make their lives more convenient; and the introduction of high-quality brand businesses of various levels shall be supported to help improve the commercial level of the Lin-gang Special Area.

To ramp up support for the development of the cultural industry in the Lin-gang Special Area, *Several Policies of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone for Promoting the Development of the Cultural Industry* was formulated after research and study. According to the document, efforts shall be made to support the growth of film and television, art performance, digital culture, artwork, creative design, publication, manufacturing of cultural equipment, and other cultural industries, and promote the integrated development of culture with that of tourism, sports, science & technology, commerce, finance, and trade, etc.

To promote the high-quality development of the Lin-gang Special Area's tourism and sports industries, *Several Policies of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone for Promoting the High-quality Development of Tourism and Sports Industries* was formulated after research and study. The policies are designed to support enterprises and institutions in the tourism and sports industries whose industrial and commercial registration places, actual places of business and fiscal and taxation household places are

in the industry-city integration area (386 km²) of the Lin-gang Special Area, and related supporting service enterprises and institutions, as well as major projects and brand activities related to the tourism and sports industries that can be included in the scope of support upon determination.

Legal Services Industry

Policies: In order to attract more well-known legal services institutions and top legal talent from home and abroad to the Lin-gang Special Area, *Several Policies for Promoting the Legal Service Industry in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* was formulated after research and study. Support is provided for the following institutions: business institutions established in the Lin-gang Special Area by domestic and overseas arbitral, mediation and other dispute resolution institutions; law firms, as well as legal service organizations or institutions that deal in notarization, forensic identification and evaluation, ascertainment of extraterritorial laws; and other organizations or institutions that either contribute to the legal service industry in the Lin-gang Special Area to go global or strengthen its international legal cooperation and exchanges.

Services and Guarantees

Excellent Business Environment

Aligning with the free trade parks that are internationally recognized for their unrivaled competitiveness and referring to the 3.0 version of Shanghai's business environment reform plan formulated as per the highest standards of international economic and trade agreements, the Lin-gang Special Area plans to build itself into a business environment highland with demonstration effects both in Shanghai and across China, and with great influence across the world in three years. According to the *Report on the Business Environment Development of the Lin-gang Special Area* released on June 12, 2020, under the World Bank's business environment indicator system, the business environ-

ment of the Lin-gang Special Area approximates the world-leading level. The overall business environment of the Lin-gang Special Area is in the second tier in the world, with some indicators reaching the leading level. Furthermore, the Lin-gang Special Area has formed a mature service and guarantee system for major projects, as well as high-quality institutional guarantees for domestic enterprises, and its public service quality has also been significantly improved.

Service Specialist Mechanism

In order to guarantee the investment solicitation service, the Lin-gang Special Area has launched the “investment solicitation specialist service” and the “double-specialist mechanism for enterprise and talent service” to provide “one-stop” services for enterprises and projects in the Lin-gang Special Area, from investment negotiation, project launching, industrial and commercial registration, taxation, to land obtainment, kick-off, completion, production, and achievement of the production goal. At the same time, the “one + three + six months” working mechanism and standards will be gradually formed, striving to complete negotiation and contract signing within one month, start land supply within three months, and start construction within six months.

Simplified Approval Process for Tesla

As the largest foreign-invested manufacturing project in Shanghai, Tesla Giga Shanghai acquired lease for

land three months after signing the contract, started construction two months after acquiring the land, and obtained the first comprehensive acceptance certificate seven months after the construction kicked off. The Gigafactory was fully put into operation in ten months. Tesla Giga Shanghai has achieved the goal of “construction, completion, production, and delivering products in the same year,” epitomizing “Shanghai Service and Lin-gang Speed” to the world.

The achievement of “Tesla Speed” owes to precise services provided in accordance with the “operational-map-style” planning and the integration of the four approval services, namely “authority integration, window integration, information integration, and service integration”. In order to solidify the “Tesla Experience,” the Lin-gang Special Area has established a new integrated approval service and reform work system, and introduced a number of reform measures to amplify the spillover effect of the “Tesla Experience”. It took five months to complete a Tesla Gigafactory. By referring to “Tesla Experience,” projects like Lanwan JinPyeng New Energy and ZhenGe Biotech went through the process from signing strategic contracts to obtaining land and starting construction in four to six months, surpassing “Tesla Speed”.

High-quality One-stop Legal Services

The arbitration, mediation, notarization agencies and law firms in the Lin-gang Special Area Legal Service

Center serve the enterprises and people in the Lin-gang Special Area. It brings together multiple functions, including one-stop dispute resolution, commercial arbitration, commercial financial mediation, notarization service, public welfare legal consultation, serving the enterprises and talent in the Lin-gang Special Area in various fields such as intellectual property protection, financial legal risk prevention, asset management, labour & employment, mergers & acquisitions, and venture capital.

Intellectual Property Protection

Established in Lin-gang at the end of 2019, the Global Cross-border Technology Trade Center achieved international certification of intellectual property rights,

and included intellectual property rights in the trading market to provide better protection. The Shanghai No. 3 Intermediate People's Court issued the *Implementation Opinions on Serving and Guaranteeing the Construction of the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone and Further Optimizing the Business Environment*, to strengthen the trial of patent, copyright, trademark, and trade secret cases that may be involved in related industries, and effectively enhance the judicial protection of intellectual property rights. The Lin-gang Special Area Intellectual Property Protection Center of Shanghai People's Procuratorate provides around-the-clock consulting services on criminal and commercial cases, and handles tip-offs on intellectual property violations and crimes in the Lin-gang Special Area as well as related reports and complaints. A series of combined measures in the field of intellectual property protection will protect enterprises in a more effective way.

Convenient Talent Service Policies

In order to further attract high-caliber overseas talent and create a highland of talent at home and abroad with vitality of innovation, the Lin-gang Special Area is committed to building a more free and convenient personnel management system, relaxing restrictions on the employment of high-end talent in the modern service industry, and implementing more open and convenient policies and measures regarding the entry and exit,

stay and residence, work, and life. of personnel, so that high-level foreign talent can give full play to their expertise and become an important new force in the construction of the open industrial system of the Lin-gang Special Area.

More Convenient Entry and Exit, Stay, and Residence

The Lin-gang Special Area has formed a new mechanism for high-level foreign talent to apply for permanent residence upon recommendation. Eligible foreign high-level talent can directly apply for permanent residence in China after being recommended by the Lin-gang Special Area Administration, and the time limit for approval will also be shortened. Foreign Chinese who have worked in universities, scientific research institutes, enterprises, or other organizations in the Lin-gang Special Area for four consecutive years and have actually lived in China for no less than six

months each year can apply for permanent residence in China (and their foreign spouses and minor children can apply together). Foreign talent employed or invited by entities in the Lin-gang Special Area can apply for a residence permit for up to five years, and those who meet certain requirements after three years can apply for permanent residence in China. Foreign personnel invited by entities in the Lin-gang Special Area can apply for corresponding port visas online in advance. After obtaining permission online, they only need to confirm the visa information through the electronic system when arriving at the Shanghai port before entering China.

Faster Processing of Work Permit for Foreigners and Talent Visa

For foreign talent in high-tech fields and foreign skilled talent who intend to work in the Lin-gang Special Area as well as foreign talent employed by entities in line with the industry development direction of the Lin-gang Special Area, restrictions over age, education, and work experience will be relaxed, and a work permit for no less than two years shall be granted at one time. Green channels for work permits will also be established for overseas high-level talent such as scientific research and innovation leaders and teams. Foreign talent may be awarded encouraging extra points for points-based foreigner work permits in China and foreign talent visas. And a credit record system for employers will also be established.

Relaxation of Restrictions on the Employment of High-end Talent in the Modern Service Industry

Professionals with overseas professional certificates in the fields of finance, architecture, planning, design, and other fields can provide services in the Lin-gang Special Area after registration, and their overseas working experience can be regarded as domestic experience. Foreigners that are employed legally in the Lin-gang Special Area can apply to sit for China's professional qualification examinations for communications, accounting, and motor vehicle inspection and maintenance, etc. in the Lin-gang Special Area in accordance with regulations, except for those involving national sovereignty and security.

Attractive Individual Income Tax Rates

Eligible overseas high-end and urgently-needed talent working in the Lin-gang Special Area can be granted a subsidy. The subsidy is calculated as the difference between one's individual income tax (IIT) paid on eligible personal income and 15% of the taxable value of the same eligible income as follows: Subsidy amount = Amount of IIT paid on eligible personal income – the taxable value of eligible personal income \times 15% .

Other Guarantees

Subsidizing Interest on Financial Loans

In order to increase financial support for key industries in the Lin-gang Special Area, the Lin-gang

Special Area Administration has successively released the *Implementation Opinions on Subsidizing Interest on Loans to Key Enterprises in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone*, *Implementation Rules for the Management of Subsidizing Interest on Loans to New Infrastructure Construction Projects in the Lin-gang Special Area of China (Shanghai) Pilot Free Trade Zone* and other policies to support enterprises that meet the functional positioning and industrial development direction of the Lin-gang Special Area. The policies on interest subsidy reduce corporate financing costs, and provide special funding for interest subsidy to support new infrastructure construction projects in the Lin-gang Special Area.

Taxation Policies

Enterprises engaged in the production and R&D of core links in key areas such as integrated circuits, artificial intelligence, biomedicine, and civil aviation in the Lin-gang Special Area will be levied at a reduced

corporate income tax rate of 15% within five years from the date of establishment. Efforts will be put to accelerate the implementation of taxation polices with regard to individual income tax (IIT) subsidies for overseas talent, levies on cargoes and trade in services within the physically fenced area, and valued-added tax (VAT) rate applied to exported service. The Lin-gang Special Area will take the lead in implementing 17 innovative taxation administration service measures such as implementing “no tax return filing is required if no tax or invoice is involved” and allowing the branch offices registered in the Lin-gang Special Area of production enterprises in Shanghai Municipality to be taxed under territorial jurisdiction.

Land Use Policies

To regulate the implementation of land supply management and planning, and carry out industrial performance evaluation for enterprises within the area,

the Lin-gang Special Area issued the *Implementation Opinions on Increasing Plot Ratios of Land Used for Industrial and R&D Purposes in the Lin-gang Special Area* upon research, aiming to encourage high-quality industrial projects to increase plot ratios and underground space; simplify the procedures for industrial land planning and adjustment; and reduce the cost of land expansion for high-quality industries.

The Lin-gang Special Area issued the *Implementation Opinions on Supporting Parks and Platforms in the Lin-gang Special Area to Enhance Innovation Service Capability* upon research, to provide support for platform enterprises that have been certified to undertake the development, construction, operation and management of various parks in terms of obtainment of new land, acquisition of stock land, reduction of land cost for parks and platforms, innovation of land use policies, encouragement of mixed land use, property transfer, and leasing, etc.

Support Services

School Education

The Lin-gang Special Area currently has 46 schools of various levels and types. In the future, it will develop a nursery and pre-school public service system that is universally beneficial, safe, high-quality, diverse and inclusive, and increase the number of integrated nursery and childcare institutions. A batch of model school district education groups led by Shanghai's experi-

mental model high schools and including schools for compulsory education will be built. Some high-quality high schools including the No. 2 High School of East China Normal University (Lin-gang Campus) are in preparation. The Lin-gang Special Area will introduce high-level German vocational colleges, high-quality international education brands including Yew Wah, and set up schools for children of foreign personnel to meet the schooling needs of children of overseas talent.

Health Care

The Lin-gang Special Area currently has established a medical service system led by tertiary hospitals and based on community health service centres. In the future, it will comprehensively improve the level of

public health services, establish a disease prevention and control centre, strengthen medical service capabilities on the community level, establish one community health service centre in every town and sub-district, promote the construction of the Lin-gang Branch of the Shanghai Sixth People's Hospital, actively introduce international private hospitals, and strive for greater openness and exploration in the medical field. Drugs and medical devices that have been approved for sale abroad will be first used in the Lin-gang Special Area.

Commerce

The Lin-gang Special Area currently has a total commercial area of 450,000 m², with eight integrated commercial complexes. In the future, the Lin-gang Special Area will take the Dishui Lake and the three corridors around the lake as its core to plan business layout, build an international and professional landmark commercial

complex and commercial blocks, and attract businesses to open their first stores in China or even Asia here.

Cultural Facilities

The Lin-gang Special Area is home to the China

Maritime Museum, currently the only national-level maritime museum in China, and Shanghai Haichang Ocean Park, etc. In the future, it will also build and operate the world's largest planetarium, an indoor snow world, and a world's water sports centre, etc., and organize large-scale cultural and sports events such as Ode

to Joy by the Dishui Lake, Shanghai International Half Marathon, and special winter sports.

Transportation

The Lin-gang Special Area will create a “15/30/60/90-minute” commuting circle, i.e., reaching Shanghai Pudong International Airport in 15 minutes, Longyang Road Hub in 30 minutes, Shanghai Hongqiao International Airport in 60 minutes, and major cities in the Yangtze River Delta in 90 minutes. The Shanghai Rail Transit Lianggang Express Line to break ground in 2021 will connect Nanhui New City and Shanghai Pudong International Airport, and the one-way commuting time between them will be reduced to 15 minutes after it is completed and opened to traffic. In addition, the newly built S3 Expressway and Lianggang Avenue have helped achieve rapid multi-channel connections with

downtown Shanghai, Pudong, and Fengxian Districts. By advancing the construction of Shanghai-Nantong Railway (Phase II), Huzhahang Railway, and other external channels, Lin-gang’s connection with Shanghai East Railway Station and adjacent cities in the Yangtze River Delta will be strengthened.

The Medium-traffic T1 Demonstration Line in the Lin-gang Special Area uses the new-generation clean

energy rail tram with a length of 30 m, and a maximum operating speed of 70 km/h. A three-carriage single tram has a maximum capacity of 302 passengers. As the world's first digital-rail rubber-tired tram for the modern, open, high-tech, and creative Lin-gang, the vehicle was independently developed by CRRC Nanjing Puzhen Co., Ltd. on the basis of its up-front mature vehicle manufacturing technology platform. With the help of the magnetic marker-based virtual digital rail technology of Shanghai Electric, the vehicle boasts more accurate positioning, realizes horizontal and vertical control, and is thus safer and more reliable. The vehicle has an axle load of seven tons, with strong adaptability to roads and less demand for road reconstruction. The stored energy of super capacitors can last for more than 30 km in a single journey, making the vehicle more eco-friendly and energy-efficient.

Ecological Greening

Rich in water resources, Lin-gang is blessed with unique ecological resources such as coastal water system, woodlands, and wetlands. The Dishui Lake, located in the downtown area of Lin-gang, has a diameter of 2.5 km and covers a total area of 5.56 km². It is currently the largest artificial lake in China. On the lake are

three islands with different characteristics in the north, west, and south respectively. The greening and water coverage rate of downtown Lin-gang is as high as 65%, and the $PM_{2.5}$ level here remains around 30 throughout the year. The Lin-gang Special Area will strengthen the protection of ecological areas such as rivers, lakes, woodlands, and wildlife habitats, promote the construction of riverside greenways along the coastline, country parks, and urban parks, and advance the integration of ecological spaces with recreational spaces for citizens. Looking into the future, Lin-gang is committed to building a low-carbon and waste-free garden city.
